Chief Vigilance officer(CVO), Ministry of Commerce and Industry, Department of Commerce, Supply Division, New Delhi, has vide order No. C-37011/1/2006-V(DOC) dated 01.02.2010 under which CVO ordered that Departments /Ministries/ offices of the Government of India are forbidden to have commercial/business dealing with M/s. Shree Shyam Pulp & Board mills Ltd., A-257, Road no. 6, NH-8, Mahipalpur, New Delhi-110037 and its subsidiaries, if any.

2. The ban of Commercial/business dealings with the firm by the Government in the non-statutory sphere will be operative for a period of 4 years commencing from the date of 24.02.2010

An order no. C-37011/1/2006-V(DOC) dated 24.02.2010 was passed by the Chief Vigilance Officer Department of Commerce for banning of business dealings of M/s. Shree Shyam Pulp & Board mills Ltd. with all the Departments/Ministries/Offices of Govt.of India for a period of 4 years commencing from 24/02/10. In compliance to that this office circulated the banning order vide circular of even no. dated 10/03/2010.

Subsequently firm had filed an appeal as per remedy available to them.The instant appeal filed by the firm was examined and thereafter a personal hearing was given to the firm by the appellate authority who has decided that ends of justice would be met in the case if the period of ban on M/s. Shree Shyam Pulp & Board mills Ltd. is reduced to the one year effective from the date of ban order i.e dated 24/02/10.
